## USGA RULES GOVERN ALL PLAY

## Except As Modified By Local Rules

- Out of bounds defined by white stakes and lines.
- Water penalty areas defined by yellow stakes and lines.
- · Lateral penalty areas defined by red stakes and lines.
- All memorial gardens and flower beds are mandatory free relief.
- All French drains are considered ground under repair.
- If a player's ball is within two club lengths of a fixed sprinkler head which is located within two club lengths of the green, the player may take relief for line of play. The player may lift, clean, and drop the ball no nearer the hole and free of the intervention by the sprinkler head.

Standard pace of play is 4 hours and 15 minutes, all players are responsible for keeping up with the group in front of them.
